ABOUT THE PRODUCT	A Holiday Coast i-Saver Account is an Internet-based account that earns your savings a premium interest rate without being locked into a term deposit or cash management account. Funds are accessible at anytime through your nominated account with Holiday Coast Credit Union or another Financial Institution.
ELIGIBILITY	To be eligible for this account, you must be registered for our Internet Banking or Telephone Banking. There are no age restrictions on this high interest savings account.
INTEREST RATE	A flexible account with tiered interest. The higher rate of interest is paid on the full balance once that tier has been reached. Interest is calculated daily and paid into the account monthly. Current interest rates applicable to this account are available by calling 1300 365 7 24, visiting www.hccu.com.au or your local branch.
MINIMUM BALANCE	No minimum balance
MAXIMUM BALANCE	Maximum balance of \$1,000,000.00 unless special arrangements have been made.
TRANSACTION / ACCOUNT KEEPING FEE	There are no on-going account keeping fees or transaction fees associated with this product. Many financial institutions now charge monthly or annual administration fees on some accounts. When comparing, don't just look at the interest rate; consider the 'total cost'.

STATEMENTS	Statements are issued to all members at the end of June and December at no cost, however you may choose to receive your statements more frequently (monthly or quarterly). Please note that a fee does apply to receive more frequent statements. We also provide electronic statement service for our Members. There is no charge for the Electronic Statement service.
